We just want to say thank you to the men and women who have served our country and fought for freedom and protection. We have been fighting hard to get our 100% disabled veterans cases expedited in accordance with

the Social Security policy that was issued on March 17th, 2014 which stated that 100% VA disabled veterans are entitled to expedited processing of their claims. It's been over a year and a half since this policy was issued, and we have seen some mixed results from it. For some of our clients, we have been able to get their applications and hearing dates expedited quickly with no problem. For others, we have really had to fight with the local Social Security office and hearing office to get them to recognize that our 100% VA disabled client is entitled to an expedited processing.

The trend that our senior paralegal, Patrice, has noticed is that the policy is not being applied uniformly through all of the local offices. Depending on our clients' geographical location and the local SSA office or hearing office that applies to that client's location, we see different responses to the SSA policy regarding the 100% VA disabled veterans.

Regardless, we will continue to fight and serve our veterans through this process as they have for us and their country.
