How Is My Social Security Medical File Developed?

Initial, Reconsideration, and Hearing Level



A common question we get from our clients is how their medical file is developed. How your medical file is developed and who develops it, is affected by what level the appeals process is at - Initial (when you first apply), Reconsideration (appealing an initial denial), or Hearing level (when you see a Judge about your case).

Generally, file development is the same at the Initial and Reconsideration level. At these levels, the claim is assigned to the local Social Security Administration (SSA) Office. This office handles everything from name changes, marriage certificates, initial and reconsideration disability claims and everything else in between. The local SSA office is responsible for gathering information from the claimant and the claimant's attorney. Typically this result in **... Read More.**

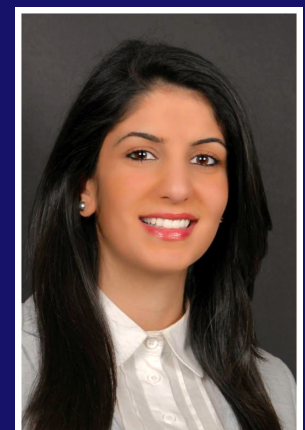
