

New Developments in Social Security Law: **25 New Conditions Added To The List Of Compassional Allowances**

It is no secret that the Social Security Disability process is a very long, tedious, and technical process. Just in the Georgia area, it takes an average of 24 months from the time you apply to the time you get to prove your case at a hearing before an Administrative Law Judge. This lag time can be detrimental to you if you are suffering from poor health, not able to work, and cannot afford health insurance and medical care.



But under the Social Security's Compassionate Allowances (CAL) provision, the Social Security Administration is obligated to quickly award disability benefits to claimants whose conditions are so severe that just by the nature of their medical diagnosis they meet the definition of disability; these medical diagnoses fall under the severe impairments that are listed under CAL.

Rather than waiting months or years to gain disability benefits, under CAL claimants may receive disability benefits within weeks. There are a few factors that may affect how quickly the benefits are processed under CAL; these factors include: how fast Social Security can obtain your medical records from your doctors; if a medical source statement by a medical examiner or your doctor is needed to support your disability claim; and sometimes Social Security randomly selects disability claims for a quality review.

The medical conditions that are selected to meet the CAL standard are determined on an annual basis through public outreach hearings that the Social Security Administration holds. In January of 2014, the Social Security Administration announced 25 new conditions that fall under CAL; there are now 225 conditions that fall under this standard. The new conditions mainly involve impairments related to the digestive, neurological, immune, and multiple body systems; a dozen out of the 25 new conditions are cancer related diagnoses.
