I seriously was not at all sure what had happened. At one point when the judge asked me about my injury or something to do with being discharged for the injury, I fell into PTSD. So, I was not sure how the rest of what I testified meant. I just answered the questions full of truth and feeling. Sara, I realized later that what I felt the most was not necessarily a win in terms of money, although I am absolutely relieved to have support, but that I was seen and heard as a disabled veteran. Having done the best I could in everything including at the VA, and that somewhere in all of that others actions have responsibility too but I am not responsible to carry their burden of responsibility in their actions when it involves not accommodating a disabled veteran for gainful employment. I will use this feeling and freedom now in pursuing my VA claim. It sure has given me a boost of awareness and honesty toward myself and given me a sense of my own identity and peace of mind back.

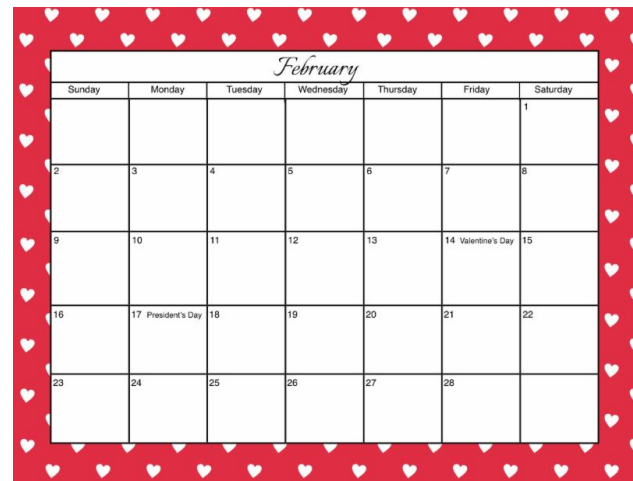


**Sara Khaki Named Super Lawyers Rising Star
