Becky Berry Career Coaching

Patrice's Success Stories:

From the Courtroom



This client success story sticks out to us because of her spirit. She has a "it's not over until the fat lady sings" mentality, and even then it's not over. We'll call her Ms. Smith. Ms. Smith originally contacted us at the end of 2014, and we subsequently closed her case due to no contact. We later found out it was because she was homeless and moving from couch to couch. However, she persevered, and we were able to complete the intake process in late February 2015.

Ms. Smith has worked as a server on and off for over 27 years. She was

considered a full time employee which gave her health benefits, but she didn't actually make

enough to pay co-pays and deductibles for the medical treatment she so desperately needed. Eventually, she had to leave her job due to her medical situation. Unfortunately, because of the cost, she wasn't able to get regular treatment which is very important when applying for disability.

We had a lot of things against us in this case: only 2 hospital visit records, 1 physical consultative examination. Both were unfavorable for our client. Going into our pre-hearing conference, we knew we had to prepare Ms. Smith for the big challenge we had ahead. We told her that we were going to argue

in the moments when you think you can't go on but you keep going anyway."

"Strength grows

that she met the GRID rules - meaning that she was over 55, and it would take more than minimal vocational adjustments for her to learn a new job.

During the hearing, Ms. Smith testified that she couldn't afford the co-pays and deductibles of the health insurance that she had, she was homeless which is why there were no medical records around her onset date, and that her last employer made work accommodations for her. While the judge asked if we would agree to amend the onset date, we said we would not based on all this information plus the fact that she meets the GRID rules. In addition, when the client was proposed hypothetical scenarios, it was clear that there were no gainful employment opportunities for her. The judge really seemed receptive to our arguments, and we left feeling really good about the case despite the facts that were so tough to overcome. Two weeks later, we received a fully favorable decision due to the fact that she was found disabled under the GRID rule 202.06. Ms. Smith couldn't be more pleased, and neither could we. Despite insurmountable circumstances, we prevailed, and Ms. Smith's life is permanently changes for the better. She can now afford to start getting the regular medical treatment she needs.
